The staff of Blue Bird experienced something during the night of August 20th that no one could have anticipated. Consumer Tracy Everett, who was a special part of FCS, died unexpectedly.

Throughout the tragic events of that evening, the staff at Blue Bird maintained a safe and comfortable environment during the time of loss. They

tended to the needs of the consumers of the program first; putting their own grief aside for the sake of our consumers.

Brenda Jiminez responded immediately, ready to administer CPR and first aid if possible. In the face of great tragedy and shock, she maintained her composure, and ensured that the scene was safe until the authorities arrived. **Betsy Cruz** spoke with law enforcement and the EMT's, sharing Tracy's information. The team at Blue Bird worked compassionately and professionally throughout the long evening and in the days and weeks following Tracy's passing.
